Standard Broker Fees:

\$500.00 or 10% (whichever is less) and \$135.00 Risk-Management fee per standard single agency transaction up to \$1 million. There are no sign-up, recurring, monthly, hidden or other fees that an Associate-Licensee will be charged while performing common real estate business in California.

Recruiting Bonus:

For every agent that you refer to pay1Realty.com you will receive a \$100.00 recruiting bonus for each of their qualified* closed transactions where the full Broker commission of \$635.00 is paid. There is no limit to the number of agents you refer or the number of bonuses you can receive. When your recruited agent registers online at www.reebroker.com they must simply state your name in the "referred by" area of the application. The bonus will be paid automatically to you as long as the referred agent remains with pay1Realty.com.

Note: Recruiting Bonus is not applicable when referring a spouse or agents working as a team.
